O R D E R

[10] The court will arrange for the publication of this Order in the national register of non-governmental organisations.

[11] No appeal may lie from this Order. The prosecutor and the person whom the Order concerns may file a lawsuit - in respect of the part of the Order concerning him/her - against the association for the annulment of the present Order, in case the Order or the procedure on which the Order is based, or the documents attached to the application, are in violation of the law. In such cases, the court having jurisdiction over the seat of the organisation is in

charge. The lawsuit must be filed within sixty days of the publication of this Order in the national register. Failure to meet this deadline will result in forfeiture of legal rights.

J U S T I F I C A T I O N

[1] The person exercising the founding rights has submitted a request to register the changes in the Foundation's record.

[2] With regard to the amendments, the application and its annexes are in compliance with Act V of 2013 on the Civil Code; Act CLXXV of 2011 on the Right of Association, Public Benefit Status and the Operation and Support of Non-Governmental Organisations; and Act CLXXXI of 2011 on the Court Register of Non-Governmental Organisations and the Related Procedural Rules.

[3] Therefore, the court has ruled in accordance with the relevant section of Article 37 (1) of Act CLXXXI following from Article 30 (1) of Act CLXXXI.

[4] The exclusion of the right of appeal and the possibility of filing a lawsuit are founded on Articles 46/A (1) and (2) of Act CLXXXI.
